#### 46. Discussion of Possible Models for Interviews 2023-24

The Admissions Tutor provided an update on the situation regarding plans for interviews across the colleges for the 2023-2024 admissions cycle, informing the Governing Body that the College was the last to declare its position and that most colleges planned to run interviews online. The Admissions Tutor emphasised that once a decision was made the College must communicate its position clearly to potential applicants. The Admissions Tutor also reminded Governing Body that it must be conscious of the risk that any model of interviewing could be considered discriminatory.

Governing Body considered a range of views regarding whether the College should adopt an online or in person model of interviewing for the 2023-2024 admissions cycle. Issues such as cost, interviewee experience, technology, Widening Participation candidate impact, and the positions declared by other

Colleges were discussed. Governing Body also considered University and College admissions data from recent admissions cycles, along with the findings of a survey of University applicants.

Governing Body noted that whilst online interviewing was broadly fit for purpose, and had advantages in terms of accessibility, an online model could inhibit communication between interviewer and interviewee.

However, experiences, and views about the effectiveness, of online interviewing varied by subject area.

Emphasis was placed upon the importance of assessing experiences and outcomes of the interview process in 2023 to enable College to make a more informed decision prior to the 2024-2025 admissions cycle. There was some preference for this to be undertaken at University level, but the Admissions Tutor reassured Governing Body that she would undertake similar work within College.

#### Governing Body agreed:

i) To commit, in principle, to a model of in-person interviewing for the 2023-24 Admissions round.

Twenty-five votes were cast in favour of committing in principle to a model of online interviewing for the 2023-2024 admissions round, and twenty-six votes were cast in favour of committing in principle to a model of in-person interviewing for the 2023-2024 admissions round.

ii) As Governing Body had voted to commit in principle to a model of inperson interviewing for the 2023-24 admissions round, to adopt Model 3, whereby all candidates resident or schooled in the UK will be interviewed in-person, but all candidates resident or schooled overseas will be interviewed online.

Eighteen votes were cast in favour of adopting Model 2 presented by the Admissions Tutor (whereby all candidates will be interviewed in person, regardless of whether or not they are resident/schooled overseas), and thirty-two votes were cast in favour of adopting Model 3 (whereby all candidates resident or schooled in the UK will be interviewed in-person, but all candidates resident or schooled overseas will be interviewed online).

iii) To allow students resident/schools overseas to be interviewed in person on request.

Governing Body voted in favour of allowing students resident or at school overseas to be interviewed in person in request by a large majority.

## 48. Discussion of Possible Models for Interviews 2023-24

The Admissions Tutor presented a paper to Governing Body regarding interview format at Cambridge for the 2023-2024 admissions cycle.

The Admissions Tutor provided updated information to GB regarding her understanding of the approach being adopted by other colleges, noting the shortcomings of the consultation process led by the Senior Tutors' Committee (STC). The Admissions Tutor informed GB that the majority of colleges had declared they would run interviews online only, but that there was no consensus amongst colleges as others were adopting hybrid models and some had not yet declared a position. The Admissions Tutor noted the additional expenditure and potential legal risks to the College which may arise depending on what model GB decides to adapt. The Admissions Tutor emphasised that any model GB choses must be deliverable by the Admissions team.

GB agreed to modify the vote originally put forward by the Admissions Tutor. GB agreed to a first vote on whether to adopt the principle of online interviews or in person interviews. If GB are to vote in favour of in-person interviews, a vote will then be held on whether in-person interviews are held for UK candidates only (with overseas candidates being interviewed online) or for all candidates.

GB considered whether College needed to adapt a single approach for all subjects, but noted that a mixed model would not be deliverable in practice.

GB noted that it was important that Colleges were not 'locked in' to the approach they adopt this year. The Admissions Tutor undertook to provide GB with a review of the 2023-24 Admissions round in order to inform future decisions.

Members of GB put forward differing views of their experiences of online interviews in comparison to in-person interviews. Some members of GB expressed the view that in-person interviews can give candidates a better opportunity to demonstrate their personality and their full potential, however other members felt there was little difference between online and in-person interviews in this regard. GB noted that different subject groups had different experiences and views of the effectiveness of online interviews. GB agreed that, in order to achieve the best possible outcomes during the upcoming Admissions round, subject areas would need to collaborate on how to adapt interviews for a digital format (if GB chose to select such a model).

Additionally, GB noted the importance of interviews being conducted as fairly as possible.

GB expressed dissatisfaction at how the issue of the Admissions round had been managed at University level and that a uniform approach across the colleges had not been established. The Senior Tutor emphasised that, regardless of the decision GB made by GB regarding the 2023-2024 Admissions cycle, those conducting interviews must not discriminate against candidates taken from the pool that have been interviewed by another mechanism.

A vote to decide whether the College will hold in-person or online interviews in the 2023-2024 Admissions round and, if GB votes in favour of in-person interviews, whether to hold in-person interviews for all candidates or UK candidates only, will be held at an Extraordinary Congregation to be held on Thursday 8th June 2023.
