OPEN BUSINESS

45. In Memory – The Hon. Geoffrey Wilson CVO

The Members of Governing Body stood in memory of The Hon. Geoffrey Wilson, Fellow Commoner.

47. Minutes of open business of the Ordinary Congregation held on 14 March 2024

48. **Matters arising from the minutes**

49. **Oral reports**

The Senior Tutor reported on a University consultation about exam resits. Informal proposals had been made to replace the EAMC system with a resit period each September. She sought Governing Body's views on the proposal.

Governing Body acknowledged that Cambridge University's approach to resits is abnormal amongst UK Universities.

Members of Governing Body highlighted the additional administrative burden a resit period would place upon academic staff and the erosion of the Summer Research Period. but noted that students might benefit from the opportunity to resit exams.

Governing Body also noted that students, for instance those who need to work during the vacations, would be negatively impacted by a resit system although others might benefit. The representative for KCSU informed Governing Body that King's undergraduates had responded negatively to the proposals when consulted by KCSU; the medics, who could already resit examinations, did not have a positive view of the resit system.

Governing Body invited the Senior Tutor to convene an informal session in which a more extensive discussion could take place. The Senior Tutor thanked Governing Body for their comments.

Principal business

50. Audit & Scrutiny Committee Terms of Reference – External Members

The Vice Provost presented Council's comments on how an external member of the Audit and Scrutiny Committee should be appointed and what their role in the Committee should be.

Council had been responding to comments provided by the internal members of the Committee. Council and the Audit and Scrutiny Committee agreed on a method of appointment, but Council's view was that the Audit and Scrutiny Committee's proposals would not allow the external member to be fully effective on the Committee. Governing Body were asked to agree terms of reference for the Committee which would reflect its preferred model.

Members of Governing Body noted the value external members can bring to College committees and favoured their full engagement, particular in support of audit functions.

A fast-track appointment model had been proposed for this year only in order to ensure external membership during 2024. Governing Body broadly supported the model but felt that Council (not the Audit and Scrutiny Committee) should shortlist the candidates and appoint their preference.

Governing Body agreed:

a) To agree terms of reference of the Audit and Scrutiny Committee based on Council's preferred model; and

b) To adopt a 'fast-track' appointment process for the external member for this year only (in which Council will appoint a candidate from amongst those nominated by Fellows).

51. Free Speech Code of Practice

The First Bursar presented Governing Body with a new Free Speech Code of Practice, recommended by Council. The College is required to adopt a Code of Practice in order to comply with new legislation.

Governing Body discussed the language used in the Code and noted that the College may remain vulnerable to challenge even if it acted in compliance with its Code of Practice.

Governing Body raised concerns about the College's expanded legal duties with regard to free speech and how (notwithstanding the College's commitment to acting in a way that supports free speech and academic freedom) they may expose the College to greater risk of litigation.

The First Bursar reassured Governing Body that the Code had been developed in a way that was mindful of some of the challenges and uncertainties posed by the new legislation (management of commercial events, for example). He emphasised that the Code would remain subject to review by Council.

Governing Body agreed:

a) To adopt the Free Speech Code of Practice appended to the paper from 1 August 2024, subject to ongoing review by Council.

52. Amendment to Ordinances – Dissolution of the SEC (Second Reading)

On 14 March 2024 Governing Body approved an amendment to Ordinances C.2.2 and C.2.7. The amendment removes reference to the Studentship Electors Committee from the College's governing documents to reflect the Committee's dissolution. The Senior Tutor brought the amendments to Governing Body again for their second reading.

Governing Body agreed:

a) To approve, for the second time, amendments to Ordinances C.2.2 and C.2.7 so they shall no longer refer to the Studentship Electors Committee.

53. Investment Committee – Terms of Reference

The Investment Committee requested an amendment to its terms of reference in order to coopt up to two additional non-resident members of College to the Committee. The First Bursar spoke to the paper.

Governing Body discussed the balance of internal and external membership of the Committee. The First Bursar's proposals would mean that external members would outnumber voting Fellows on the Committee.

Whilst Governing Body spoke highly of the role of external members on the Investment Committee and were in support of creating additional opportunities for them to contribute, Governing Body's view was that the

proposed additional members should be non-voting in order to preserve the balance of power in favour of Senior Members of the College.

The gender balance of the current committee was noted. Governing Body considered whether adding more elected Fellows to the Committee could improve this. Governing Body's preference was, instead, to remain mindful of this issue in the lead up to the next elections.

Governing Body agreed:

b) Agreed to amend the Investment Committee's terms of reference to allow the Committee to coopt additional non-voting non-resident members.

Governing Body took the opportunity to thank the current external members of the Investment Committee.
