Apologies for Absence

Apologies were received from Dr Srinivasan. Ms Hagan was absent from the meeting.

OPEN BUSINESS

46. Declarations of Interest

Council noted the timetable and action list and the update on policies.

Principal Items of Business

51 Preparing the Budget for 2021-22

Dr Wallach, as Chair of the Finance Committee, joined Council for this item. The First Bursar presented a paper on behalf of the Finance Committee suggesting to Council an approach to setting the budget for 2021-22 and beyond.

Council considered the plans for preparing the budget presented by the Finance Committee. It agreed that the Finance Committee should prepare the budget by looking at the expected income when we have returned to normal operation. That will mean that the income from visitors and conference catering, in particular, will not be achieved this year. We should then aim to set the expenditure budget to balance this income. Over the longer term, we should aim to restore the losses to the endowment by budgeting for modest surpluses.

Council requests the Investment Committee to consider again the sustainable real rate of return and the period over which we average our endowment when determining our spending rule.

Council asks the Visitor Committee and the Finance Committee to consider how the income from visitors might be smoothed over time and how we budget for this income.

Council agreed to endorse the paper and send it to the Governing Body.

Other Items for Discussion

52. Privately Funded College Fees 2022-23

The First Bursar asked Council to agree the level of fees for privately funded undergraduate students from October 2022.

Council agreed to set the College privately funded undergraduate fees for the academic year 2022-23 at:

- (i) £7,998 for students whose course begins in 2017-18;
- (ii) £8,718 for students whose course begins in 2018-19;
- (iii) £9,153 for students whose course begins in 2019-20;
- (iv) £10,068 for students whose course begins in 2020-21;
- (v) £10,470 for students whose course begins in 2021-22; and
- (vi) £10,887 for students whose course begins in 2022-23.

The fee for these students will be the same in subsequent years of the course up to the fourth year.

53. CFCI Dinner – Michaelmas Term 2021

The First Bursar asked Council to decide whether a dinner might be permitted to be held early in the Michaelmas Term.

Council agreed to give permission for the CFCI dinner to take place on 29th October or 12th November 2021. It was suggested that the other proposed date of 15th October not be offered as it was too near the start of Michaelmas Term.
