56. Oral Reports

Review of the Visiting Fellowship Policy

The Vice-Provost reported that the new procedure for electing Visiting Fellows had worked well. Congregation agreed to confirm the procedure.

Principal Business

57. Reducing Carbon Usage

The First Bursar presented a summary of the actions the College has taken to reduce our carbon footprint. While this had been effective, we will need to make further changes that will require careful study and significant investment.

58. Wild Flower Meadow on the Back Lawn

Professor Moggridge presented a proposal by the Gardens Committee to plant part of the back lawn as a wildflower meadow. This would be introduced this autumn and continue as a five year experiment. The lawn covers part of the mediaeval city and is therefore of archaeological interest. A survey of the entire College has been commissioned, using ground penetrating radar. That may lead to further investigative work.

Congregation approved the creation of a wildflower meadow on the northern part of the back lawn. Construction of the meadow will commence in November 2019.
