337. Oral reports

The First Bursar and Senior Tutor updated Council on the current arrangements for CoVid-19 both in College and the University. Numbers taking part in the pooled testing remain low. If numbers increase, the College will be able to reassess the safety of events and may be able to increase the capacity of these. The students reported that both KCSU and KCGS were trying to encourage greater participation.

Other Items for Discussion

338. Tutor for BME Students Proposal

The Senior Tutor presented a proposal to appoint Tutors specifically to support BME students.

Council agreed to appoint to these roles as soon as possible until 31st August 2022; to review the roles by the last Council meeting of this academic year, with a view to potential renewal in future years.

339. Paper from Working Group on Chapel Woodwork

The Working Party set up by Council in 2020 "to consider the aesthetic, architectural, ecclesiastical, financial and reputational issues concerning the future storage, repurposing, reinstatement or disposal of the alienated Chapel wood" delivered its report.

Council endorsed the conclusions of the Working Party and will recommend to the Governing Body:

1) that the College should seek to dispose of the Edwardian woodwork from the Detmar Blow arrangement of the east end of the Chapel, preferably to an appropriate re-use;

2) that the College should retain the Cornelius Austin panelling with the intention of re-using it within a project in King's.

Council requested that the Chapel Committee be asked to consider whether or not any use was possible within the Chapel, and report to Council and the Governing Body.

Council thought that these conclusions should be implemented as soon as practicable.

340. The Alan Turing Sculpture – Planning Permission

The Keeper of the College Collections reported on progress in securing planning permission for a possible statue commemorating Alan Turing.

Council agreed in principle that, if the planning application for the Alan Turing

sculpture is agreed by Cambridge Council, it will develop plans for regular, guided visitor access to the sculpture at a number of pre-bookable specified times, and possibly also on National Heritage Day and the days when the College opens specially for local residents.
